



# Understanding your L&I payment

Beginning Jan. 4, 2014, your L&I payment for services to injured workers or crime victims will arrive in a different envelope from L&I's *remittance advice*, the explanation for your payment.

Here's how to read the explanation that will come with your payment.

- 1 L&I Remittance Advice Number (RAN).**  
Note this number — you'll need it to match up the payment with the L&I remittance advice.
- 2 Warrant number.** A *warrant* is what the State of Washington calls this payment (which is

technically a little different from a check). The warrant number can also help match up the payment with the remittance advice.

- 3 Your L&I Provider Number.**
- 4 Your NPI number,** if we have one on record.
- 5 Coming for L&I in 2014.** When the direct deposit option becomes available, we'll notify you.
